WHEREAS the Plaintiff has filed a civil complaint alleging a cause of action for libel and libel per se;

WHEREAS the Plaintiff has signed and attested to the accuracy of the allegations in the complaint;

WHEREAS it appears that from the Plaintiff's pleadings that the Plaintiff would be successful on the merits of the claim and as part of any judgment would be entitled to some form of injunctive relief, that failure to temporarily restrain the Defendants from continuing the website, FullofBologna.com, and failure to remove the offending statements would continue to cause the Plaintiff irreparable injury to reputation, no other suitable relief is available, and that the Defendant's have failed to adequately monitor the posts on the website in question; and,

WHEREAS due to the attempts to hide the identities of the Defendants by use of false names and monikers, the need for immediate redress, and the continued publication of the offending statements,

IT IS HEREBY ORDERED that:

- 1. The Defendants are temporarily ordered to suspend all operations and publication of the website, FullofBologna.com. until further Order of this Court;
- 2. The Defendants are temporarily ordered to refrain from the design, operation, hosting or otherwise creating a similar website until further Order of this Court;
- 3. The Defendants are required to remove the offending posts listed in the Plaintiff's cause of action, any subsequent posts commenting on that post, and any republications of the post;
- 4. The Court grants the Plaintiff's request to sign the Order ex parte;
- 5. The Plaintiff is not required to post bond;
- 6. The Defendants are required to comply with this Order immediately upon receipt of the Order and provide proof of compliance with the Order to the Plaintiff's counsel within 24 hours of receipt of the Order;
- 7. Failure to comply with this Order may result in a finding of contempt, under sec. 785.01, Wis. Stats. Penalties could include: *Nonsummary procedure*: may impose for each separate contempt of court a fine of not more than \$5,000 or imprisonment in the county jail for not more than one year or both; or, *Summary procedure*: may impose for each separate contempt of court a fine of not more than \$500 or imprisonment in the county jail for not more than 30 days or both.
- 8. The parties will be required to return to this Court to review the Temporary Restraining Order within 30 days of this Order, or sooner if requested and arranged by the parties.
