DEFENDANT SHARON BAYOLO'S MOTION TO DISMISS FOR LACK OF PERSONAL JURISDICTION

Typically, the company would quote a certain fee to move the consumers' belongings. The customer would hire this company based on the quoted fee. However, once the customer's belongings were loaded and locked away on the truck, the company would demand a sum of money considerably higher sometimes thousands of dollars higher than the agreed-upon price. If the customer refused, the company would drive away with the customer's belongings and threaten to assess storage and other additional fees. (Affidavit, para. 3)
- 4. One of the websites I encountered during my research of the industry was MovingScam.com. This website features a message board where site visitors can ask questions of each other and provide information and advice about the moving process, moving estimates,

and the like. To date, tens of thousands of messages have been posted by hundreds (likely thousands) of visitors like myself to the site. (Affidavit, para. 4)

- 5. I post on the message board to answer other visitors' moving-related questions to the best of my ability, provide advice on how best to achieve a successful move, and set out other information that I believe may be of interest to consumers. I do this to help people during one of the most stressful period of their lives, when they are moving to a new residence, often far away. (Affidavit, para. 5)
- 6. Occasionally, my postings provide information and opinions on certain moving companies. My opinions are formed and based on messages posted by other consumers/site visitors describing their experiences with these companies, as well as information contained in public filings, press releases, and other materials available or disseminated to the public from agencies including the Federal Motor Carrier Safety Administration and the U.S. Attorney's Office, and newspaper articles. (Affidavit, para. 6)
- 7. I am not involved with the maintenance, management, or direction of the MovingScam.com website. Except for my postings on its message board, I am involved in no other activity associated with the website, including any commercial activity. (Affidavit, para. 7)
- 8. I receive no money or other compensation from for my involvement with the website from any person or entity, including any of the other defendants named in this lawsuit. (Affidavit, para. 8)
- 9. All messages posted by me on the website have been posted from my computer at home in New York (and previous to that, from my home in Virginia). (Affidavit, para. 9)

WHEREFORE, I, Sharon Bayolo, respectfully requests that this Court dismiss plaintiff's Complaint in its entirety.
