The plaintiff, SUSAN O'MALLEY, by her attorney JOSEPH MARTIN CARASSO, ESQ., complaining of the defendants, herein alleges as follows:

### <u>PARTIES</u>

- 1. At all times hereinafter mentioned, plaintiff SUSAN O'MALLEY was and is a resident of the City of New York, was and is a professor of English at Kingsborough Community College (hereinafter "KCC"), which is part of the City University of New York (hereinafter "CUNY"), and was and is a Professor of Liberal Studies at the CUNY Graduate School.
- 2. SUSAN O'MALLEY is a distinguished scholar and teacher. The author of many publications on early modern pamphlet literature and drama, Shakespeare, higher education, disabled women and civil rights, she has presented papers at conferences and lectures sponsored by the Shakespeare Association of America, the Society for the Study of Renaissance Women, the Modern Language Association, the Renaissance Society of America, the English Forum at the CUNY Graduate School, and Princeton University, and is a recipient of NEH, Mellon, Fulbright, Huntington Library, Folger Library and CUNY grants.
- 3. SUSAN O'MALLEY has served with distinction in various CUNY university and governance roles, including as the ex-officio Faculty Trustee of the CUNY Board of Trustees, and Chair of the CUNY University Faculty Senate (hereinafter "UFS"), the official governing body for the faculty of CUNY.
- 4. SUSAN O'MALLEY has been a member of the Professional Staff Congress (hereinafter "PSC"), the union for faculty and staff at CUNY, for many years, and was elected to numerous positions in the PSC including as a University-wide Officer, a Community College Officer, and KCC Chapter Chair.
- 5. During her long service to KCC and CUNY and as Chair of the UFS, SUSAN

O'MALLEY has acquired and retained a high standing and reputation among the CUNY academic community for her advocacy of high academic standards, accessibility of higher education, and her humanity and intelligence.

- 6. In May 2006, SUSAN O'MALLEY was the recipient of a resolution (hereinafter "Resolution") of the Executive Committee of the UFS presented and ratified by the entire Senate of the UFS, honoring her long career dedicated to governance both at KCC and in the wider CUNY community, honoring her advocacy for combining high academic standards with accessibility to higher education, her diligent work, her great humanity and her intelligence, and acclaiming SUSAN O'MALLEY as a worthy and eminent leader.
- 7. A true and complete copy of the Resolution is attached hereto as Exhibit A.
- 8. In October 24, 2006, members of the UFS presented a framed copy of the Resolution to SUSAN O'MALLEY and gave her a standing ovation for her past work and dedication.
- 9. At all times hereinafter mentioned the defendant, SHARAD KARKHANIS ("KARKHANIS"), was and is an individual residing in the City and State of New York.
- 10. KARKHANIS is currently a retired librarian of KCC.
- 11. KARKHANIS was and is at all times relevant and hereinafter mentioned, the owner and publisher of a website and email newsletter known as "The Patriot Returns," located at IP address <a href="www.patriotreturns.com">www.patriotreturns.com</a> (hereinafter "Newsletter"), which was and is circulated extensively via email to the faculty, staff, and chancellory of CUNY, the New York City Council and members of the State Legislature, and upon information and belief to thirteen thousand (13,000) recipients.
- 12. Upon information and belief, at all times relevant and hereinafter mentioned, KARKHANIS was and is the editor-in-chief of the Newsletter.
- 13. Upon information and belief, since the first publication on February 26, 1992, KARKHANIS has served as editor-in-chief and was and is a primary contributor to the Newsletter.
- 14. Upon information and belief, and at all times hereinafter mentioned JOHN DOE was and is also a contributor to the Newsletter and specifically was a contributor to Volume 35, Numbers 1, 2, 3 and 4; Volume 36, Numbers 1, 2, 3 and 4; Volume 37, Numbers 1, 2 and 3; and Volume 38, Numbers 1 and 2 of said Newsletter.
- 15. Upon information and belief, and at all times hereinafter mentioned, JANE DOE was and is also a contributor to the Newsletter and specifically was a contributor to Volume 35, Numbers 1, 2, 3 and 4; Volume 36, Numbers 1, 2, 3 and 4; Volume 37, Numbers 1, 2 and 3; and Volume

38, Numbers 1 and 2 of said Newsletter.

### MATTERS PERTAINING TO ALL CLAIMS

- 16. On or about the dates and as set forth in the paragraphs below, statements or utterances published (hereinafter the "Utterances") by the defendants KARKHANIS, JOHN DOE and JANE DOE concerning the plaintiff were and are both false and defamatory.
- 17. At the time the defendants published the defamatory Utterances set forth below, the defendants knew that the Utterances contained false statements of facts, or recklessly failed to take the proper steps to ascertain the accuracy of the Utterances, and published the Utterances with reckless disregard of whether they were true or not.
- 18. By letter (hereinafter the "Letter") dated April 18, 2007, sent by certified mail, to Karkhanis, and attached hereto as Exhibit B, plaintiff by her attorney advised KARKHANIS that portions of the Newsletter, specifically Volume 35, Number 4, published on or about March 12, 2007, contained "false, damaging and defamatory" Utterances.
- 19. In addition, the Letter stated that prior publications of the Newsletter contained defamatory Utterances.
- 20. The Letter requested that KARKHANIS retract the defamatory Utterances and refrain from making any other defamatory Utterances.
- 21. KARKHANIS never responded to the Letter.
- 22. KARKHANIS continued to publish false and defamatory Utterances about SUSAN O'MALLEY after receipt of the Letter.

### AS AND FOR A FIRST CAUSE OF ACTION FOR DEFAMATION

- 23. Plaintiff repeats, reiterates and realleges each and every allegation set forth in Paragraphs "1" through "22" inclusive, of this complaint, with the same force and effect as though more fully set forth at length herein.
- 24. Commencing on or about February 6, 2007, and continuing to the present day, the defendants published and circulated the following defamatory Utterances of and concerning the plaintiff in the Newsletter, Volume 35, Number 2, a copy of which is attached as Exhibit C, which contains the following matter, to wit:

"TERRORISTS TO TEACH AT KCC?
SAY NO TO THE QUEEN OF RELEASED TIME!
The Patriot believes that the current actions of the Queen of Released Time, Susan

O'Malley, may be rooted in her childhood.

Susan hails from a wealthy family, so money was never an issue. She decided that it should not be an issue for anyone. So advocating for a union that champions criminals and terrorists, while cutting ordinary folks' salaries, was just perfect."

and

"By intimidation and by joining radical groups, she became the leader of the University Faculty Senate, solely for the purpose of enjoying the good life, without having to dirty her hands with chalk.

In the year 2004, Susan O'Malley found out that Susan Rosenberg was asked to leave her adjunct position at John Jay College of Criminal Justice. It was the perfect time for O'Malley to come to help a convicted criminal."

and

"Was Susan trying to open an opportunity for Yousry in KCC's English Department? Was she thinking that as a Very Important Person in the University she would pressure the Chair and members of the English Department's P & B to hire Mr. Yousry? She probably thought that with all that experience transmitting written screeds and instructions from the Sheik to his terrorist minions, Yousry should be able to teach our KCC students with ease. If Mr. Yousry ever lands at KCC, be assured it is courtesy of the Queen of Released Time.

Susan believes in those who preach and practice revolutionary violence, like Susan Rosenberg. She supports the terrorist Yousry who aided fellow terrorists and murderers in a most substantive way, by conveying instructions for murderous activities, directed against us all."

and

### "LYNN STEWART AT THE PSC?

In October this year, campus cafeterias and hallways were filled with hush hush rumors: ... Lynn Stewart... will herald her joining the staff of the PSC. This would be, of course, courtesy of the Queen of Released Time for her idol in distress."

and

- O'Malley will have no trouble pushing Lynn's appointment as a PSC attorney with a sizable salary, to assist the PSC's current convicted-felon attorney, Nathaniel Charney."
- 25. By this publication, the defendant falsely and maliciously charged and was understood by those people reading the Newsletter to charge the plaintiff with being a person of vicious, disreputable, criminal and "terrorist" character, who supports "terrorist" activities at the present time in the United States, who actively goes out of her way to assist convicted criminals without any regard for the CUNY academic community, who acts purely for her own selfish reasons, and not for the best interest of the academic community, who believes in those who preach and practice terrorism or violence and murder and has the ability and influence to secure jobs for criminals and "terrorists" instead of and at the expense of decent upstanding citizens and lawabiding Americans.
- 26. Hired at KCC in 1974, SUSAN O'MALLEY has taught English for many years, has been

a full Professor of English since 1991, and has often "dirtied her hands with chalk".

- Over the course of 28 years (1974-2002), Susan O'Malley received some reassigned time for scholarly research awarded through her winning grants, some reassigned time for co-directing the College Now English Program and teaching in two high schools for the American Social History Project, some reassigned time for being elected to the Executive Committee of the UFS and as the elected KCC Union Chapter Chair for three years.
- 28. SUSAN O'MALLEY's life has been dedicated to teaching, scholarly research, and governance at KCC and CUNY.
- 29. Contrary to the defendants' Utterances, SUSAN O'MALLEY worked hard for her achievements, and did not hail from a wealthy family such that money was never an issue for her or her family.
- 30. Contrary to the defendants' Utterances, SUSAN O'MALLEY attended public schools, and raised two children on her own as a single parent.
- 31. Contrary to the defendants' Utterance, SUSAN O'MALLEY believes in and has always practiced peaceful and lawful resolution of disputes.
- 32. Contrary to the defendants' Utterances, SUSAN O'MALLEY does not believe in terrorism or violence.
- 33. Contrary to the defendants' Utterances, SUSAN O'MALLEY believes that the decision to hire faculty should be decided by faculty and not by other groups outside of the faculty departmental committees.
- 34. Contrary to the defendants' Utterances, SUSAN O'MALLEY never met Susan Rosenberg or talked to her on the telephone.
- 35. Contrary to the defendants' Utterances, the faculty at John Jay College of Criminal Law (hereinafter "John Jay") were concerned with the removal of Susan Rosenberg, and expressed outrage that they were not consulted when she was not allowed to continue teaching at John Jay because of the objections of a group outside of John Jay.
- 36. Contrary to the defendants' Utterances, it was SUSAN O'MALLEY's duty as UFS Chair to represent the views of the faculty at John Jay.
- 37. Contrary to the defendants' Utterances, Mohammed Yousry (hereinafter "Yousry") had taught part time at York College for 7 terms and had received favorable reviews. The faculty at York College wanted him to continue teaching at York College and did not understand why he was removed from the classroom in the middle of the term and forbidden to teach there again.

- 38. Upon information and belief, if Yousry had been a full-time faculty member, he could and or would not have been removed without consultation and due process.
- 39. Contrary to the defendants' utterances, SUSAN O'MALLEY represented the faculty at York College, including Yousry, which was one of her duties as UFS Chair.
- 40. Contrary to the defendants' implications, SUSAN O'MALLEY met Yousry only once at a conference, did not communicate with him at any other time, and does not support him in his alleged "terrorist" activities.
- 41. Contrary to the defendants' Utterances, SUSAN O'MALLEY supports the right of adjunct faculty, including Yousry, to receive due process and not to be removed from the classroom without consulting the head of the department that hired him.
- 42. Contrary to the defendants' Utterances, SUSAN O'MALLEY never emailed or spoke to to Lynne Stewart on the telephone, and she never invited her to join the staff of the PSC and never requested that she join the staff of the PSC.
- 43. Contrary to the defendants' Utterances, SUSAN O'MALLEY is not now and has never been in the position to hire or fire faculty, except for the six years that she was elected to the Personnel and Budget Committee (hereinafter "P & B") for the English Department of KCC in the late 1980's and early 1990's.
- 44. Contrary to the defendants' Utterances, SUSAN O'MALLEY has never pressured anyone within the University to hire any faculty at KCC or CUNY.
- 45. Contrary to the defendants' Utterances, SUSAN O'MALLEY was elected to the Chair of the UFS by a democratic vote of the faculty of CUNY, and was not elected by "intimidation."
- 46. Contrary to the defendants' Utterances, SUSAN O'MALLEY found the position of UFS Chair to be a high stress, demanding, nerve-wracking position, requiring her to be in constant communication with the faculty and the Chancellory.
- 47. At the time the defendants published the defamatory Utterances set forth above, the defendants knew that the Utterances contained both false statements of facts and false implied statements, or recklessly failed to take the proper steps to ascertain the accuracy of the material.
- 48. At the time the defendants published the defamatory Utterances set forth above, the defendants acted willfully and with actual malice toward the plaintiff SUSAN O'MALLEY.
- 49. As the result of the publication and the acts of the defendants in connection therewith, the plaintiff has been held up to public contempt, ridiculed, disgraced and prejudiced and has been irreparably injured in her good name and business reputation and has lost the esteem and respect

of her colleagues and members of the KCC and CUNY Community.

- 50. As a result of the publication and the acts of the defendants, plaintiff fears that people who know her only through the defendants' false Utterances that she associates with "terrorists" and advocates violence will harm her.
- 51. By reason of the foregoing, the plaintiff has suffered actual and punitive damages in an amount to be determined upon the trial of action.
- 52. The amount of damages sought in this action exceeds the jurisdictional limits of all lower courts which would otherwise have jurisdiction.

### AS AND FOR A SECOND CAUSE OF ACTION FOR DEFAMATION

- 53. Plaintiff repeats, reiterates and realleges each and every allegation set forth in Paragraphs "1" through "22" and "24" through "52" inclusive, of this complaint, with the same force and effect as though more fully set forth at length herein.
- 54. Commencing on or about March 7, 2007, and continuing to the present day, the defendants published and circulated the following defamatory Utterances of and concerning the plaintiff in their Newsletter, Volume 35, Number 3, a copy of which is attached as Exhibit C, which contains the following matter, to wit:

# "O'MALLEY-QUEDA TRAINING CAMP: FINDING JOBS FOR TERRORISTS A KCC EXCLUSIVE!

We believe that the newly formed "Never-Any-Action Caucus" is the creation of Susan O'Malley (aka Queen of Released Time). Her major goal is to establish a Training Camp to recruit and train, at Kingsborough, people like herself --misguided, misdirected, misinformed.

O'Malley seeks to find jobs at KCC and other CUNY colleges for people like Mohammed Yousry."

and

"O'Malley doesn't care about us -- her only concern is that Yousry should teach at CUNY.

O'Malley has also been job-searching for Susan Rosenberg,...

and

O'Malley, though, doesn't care about us -- her only concern is that Rosenberg should teach at CUNY.

and

"We believe that the above mentioned KCC individuals [Susan Farrell, Robert Singer, Jack Arnow, Robert Putz, Patrick Lloyd] were selected for the O'Malley-Queda Recruitment Camp because she thinks that 1) they all are naive and

gullible, and 2) through them, she can infiltrate the Departmental and College wide P. & B.s at KCC and at other CUNY colleges to push her PERSONAL AGENDA of finding jobs for Yousry, Rosenberg and other terrorists.

Meanwhile, remember: the Queen of Released Time is a devious, dangerous, and untrustworthy person. It may be wise to steer clear.

More to come on the Queen . . ."

- 55. By this publication, the defendant falsely and maliciously charged and was understood by those people reading the Newsletter to charge the plaintiff with being a person of vicious, disreputable, criminal and "terrorist" character, who supports "terrorist" activities at the present time in the United States, who actively goes out of her way to assist convicted criminals without any regard for the CUNY academic community, who acts purely for her own selfish reasons, and not for the best interest of the academic community, who believes in those who preach and practice terrorism or violence and murder and has the ability and influence to secure jobs for criminals and "terrorists" instead of and at the expense of decent upstanding citizens and lawabiding Americans.
- 56. Contrary to the defendants' Utterances, there is no "O'Malley-Queda Training Camp."
- 57. Contrary to the defendants' Utterances, the only entity with the authority to hire faculty is the College President upon the recommendation of the Personnel and Budget Committees for the various departments of the colleges of CUNY.
- 58. SUSAN O'MALLEY served as a member of the KCC English Department P&B for 6 years in the late 1980s and early 1990s, and during her service on the P&B no "terrorists" were hired.
- 59. Contrary to the defendants' Utterances, that except for announcing at a UFS meeting that she heard that Yousry was looking for a teaching job, SUSAN O'MALLEY has never undertaken any action to obtain a position for Yousry, or given any type of support to Yousry in any way.
- 60. The defendants' Utterances imply that SUSAN O'MALLEY gave Yousry or Susan Rosenberg emotional and or financial support, and or that SUSAN O'MALLEY somehow conspired with Yousry or Rosenberg to conduct criminal or "terrorist" activities at KCC or CUNY or elsewhere, and or that SUSAN O'MALLEY has a goal or "personal agenda" to find positions at KCC or CUNY for criminals or "terrorists", and or that SUSAN O'MALLEY has criminal and "terrorist" friends and associates, any and all of which is false and published with the intent to malign SUSAN O'MALLEY's good name and character.
- 61. Yousry, a faculty member, called the UFS, which represents all CUNY faculty, and asked if anyone had a teaching position and left his phone number at the office, and not with SUSAN O'MALLEY personally.

- 62. Upon information and belief, the UFS office personnel had access to Yousry's phone number.
- 63. At the time the defendants published the defamatory Utterances set forth above, the defendants knew that the Utterances contained both false statements of facts and false implied statements, or recklessly failed to take the proper steps to ascertain the accuracy of the material.
- 64. At the time the defendants published the defamatory Utterances set forth above, the defendants acted willfully and with actual malice toward the plaintiff SUSAN O'MALLEY.
- 65. As the result of the publication and the acts of the defendants in connection therewith, the plaintiff has been held up to public contempt, ridiculed, disgraced and prejudiced and has been irreparably injured in her good name and business reputation and has lost the esteem and respect of her colleagues and members of the KCC and CUNY Community.
- 66. As a result of the publication and the acts of the defendants, plaintiff fears that people who know her only through the defendants' false Utterances that she associates with "terrorists" and advocates violence will harm her.
- 67. By reason of the foregoing, the plaintiff has suffered actual and punitive damages in an amount to be determined upon the trial of action.
- 68. The amount of damages sought in this action exceeds the jurisdictional limits of all lower courts which would otherwise have jurisdiction.

### AS AND FOR A THIRD CAUSE OF ACTION FOR DEFAMATION

- 69. Plaintiff repeats, reiterates and realleges each and every allegation set forth in Paragraphs "1" through "22" and "24" through "52" and "54" through "68" inclusive, of this complaint, with the same force and effect as though more fully set forth at length herein.
- 70. Commencing on or about March 12, 2007, and continuing to the present day, the defendants published and circulated the following defamatory Utterances of and concerning the plaintiff in their Newsletter, Volume 35, Number 4, a copy of which is attached as Exhibit C, which contains the following matter, to wit:

"MOHAMMED ON HER MIND!

O'MALLEY'S OBSESSION WITH FINDING JOBS FOR TERRORISTS

"Queen O'Malley was so obsessed with finding a job for Mohammed Yousry,...

and

Yes, yes, Mohammed was on her mind and she was not going to rest until she got this convicted terrorist a job."

and

Our questions are:

1) Has Queen O'Malley ever made a "Job Wanted" announcement like this for a non-convicted, non-violent, peace loving American educator for a job in CUNY? There are hundreds of qualified people looking for teaching jobs. Why does she prefer convicted terrorists who are bent on harming our people and our nation, over peace-loving Americans?

and

We believe that O'Malley was so obsessed with putting Mohammed back on the CUNY payroll, that it pretty much confirms what we said in our earlier Patriot Returns (Issue 35.3), i.e., that she is recruiting naïve, innocent members of the KCC faculty into her Queda-Camp, to infiltrate college and departmental Personnel and Budget Committees in her mission --- to recruit terrorists in CUNY. Given the opportunity, she will bring in all her indicted, convicted, and freed-on-bail, terrorist-friends.

Many of us know peace loving, law abiding, never-even-convicted-for-littering citizens who need work. How many law-abiding adjunct faculty have to worry about getting their two courses in order to hold onto medical benefits!? She does not worry about the "ordinary" adjunct -- but she is worried about convicted terrorists! She will take these precious courses away and give them to terrorists and terrorist sympathizers!

By this publication, the defendant falsely and maliciously charged and was understood by those people reading the Newsletter to charge the plaintiff with being a person of vicious, disreputable, criminal and "terrorist" character, who supports "terrorist" activities at the present time in the United States, who actively goes out of her way to assist convicted criminals without any regard for the CUNY academic community, who acts purely for her own selfish reasons, and not for the best interest of the academic community, who believes in those who preach and practice terrorism or violence and murder and has the ability and influence to secure jobs for criminals and "terrorists" instead of and at the expense of decent upstanding citizens and lawabiding Americans.
- 72. Contrary to the defendants' Utterances and implications, UFS Chair SUSAN O'MALLEY's duties included representing all faculty of CUNY, (including Yousry, who was then a member of the faculty) each of whom she believes are entitled to due process.
- 73. Contrary to the defendants' Utterances, SUSAN O'MALLEY was not "obsessed" with Yousry, or with finding him a job.

- 74. Contrary to the defendants' Utterances, Yousry called the PSC, and did not call or speak with SUSAN O'MALLEY individually.
- 75. At the time the defendants published the defamatory Utterances set forth above, the defendants knew that the Utterances contained both false statements of facts and false implied statements, or recklessly failed to take the proper steps to ascertain the accuracy of the material.
- 76. At the time the defendants published the defamatory Utterances set forth above, the defendants acted willfully and with actual malice toward the plaintiff SUSAN O'MALLEY.
- 77. As the result of the publication and the acts of the defendants in connection therewith, the plaintiff has been held up to public contempt, ridiculed, disgraced and prejudiced and has been irreparably injured in her good name and business reputation and has lost the esteem and respect of her colleagues and members of the KCC and CUNY Community.
- 78. As a result of the publication and the acts of the defendants, plaintiff fears that people who know her only through the defendants' false Utterances that she associates with "terrorists" and advocates violence will harm her.
- 79. By reason of the foregoing, the plaintiff has suffered actual and punitive damages in an amount to be determined upon the trial of action.
- 80. The amount of damages sought in this action exceeds the jurisdictional limits of all lower courts which would otherwise have jurisdiction.

### AS AND FOR AN FOURTH CAUSE OF ACTION FOR DEFAMATION

- 81. Plaintiff repeats, reiterates and realleges each and every allegation set forth in Paragraphs "1" through "22" and "24" through "52", and "54" through "68" and "70" through "80" inclusive, of this complaint, with the same force and effect as though more fully set forth at length herein.
- 82. Commencing on or about April 17, 2007, and continuing to the present day, the defendants published and circulated the following defamatory Utterances of and concerning the plaintiff in their Newsletter, Volume 36, Number 4, a copy of which is attached as Exhibit C, which contains the following matter, to wit:

"O'MALLEY TO SEEK CUNY JOB OPPORTUNITIES FOR LYNN STEWART'S DAUGHTER ACCUSED OF FAKING SICK LEAVE

It has been rumored in CUNY circles that Susan O'Malley, Community College officer on the PSC Executive Committee was in contact with Brenna Stewart, 45 year old daughter of Lynn Stewart,"

and

- "... O'Malley has obtained Brenna's resume and made copies for distribution at the next Delegate Assembly. Similar to the appeal she made for terrorists Mohammed Yousry and Susan Rosenberg (The Patriot Returns Vol. 35, no. 3 and The Patriot Returns Vol.35 no. 4,) she plans again to use her PSC position to make a personal appeal to the DA to alert members to her wish for a job for Brenna in one of the CUNY units."
- "O'Malley intends to find a lucrative job for Brenna at CUNY. College Presidents, Department Chairs, be on the lookout. Brenna will be on your campus this summer, courtesy of the Queen of Released time, and you may be singled out as O'Malley's patsy."
- 83. By this publication, the defendant falsely and maliciously charged and was understood by those people reading the Newsletter to charge the plaintiff with being a person of vicious, disreputable, criminal and "terrorist" character, who supports "terrorist" activities at the present time in the United States, who actively goes out of her way to assist convicted criminals without any regard for the CUNY academic community, who acts purely for her own selfish reasons, and not for the best interest of the academic community, who believes in those who preach and practice terrorism or violence and murder and has the ability and influence to secure jobs for criminals and "terrorists" instead of and at the expense of decent upstanding citizens and lawabiding Americans.
- 84. Contrary to the defendants' Utterances, plaintiff SUSAN O'MALLEY has never met or talked to Brenna Stewart, never saw her resume, and therefore never circulated her resume and never intended to or discussed looking for a position for Brenna Stewart.
- 85. Contrary to the defendants' Utterances and the implications contained therein, plaintiff SUSAN O'MALLEY believes in peaceful resolution of disputes and the rule of law, does not believe in "terrorism" or violence, and does not support "terrorist" activities.
- 86. At the time the defendants published the defamatory Utterances set forth above, the defendants knew that the Utterances contained both false statements of facts and false implied statements, or recklessly failed to take the proper steps to ascertain the accuracy of the material.
- 87. At the time the defendants published the defamatory Utterances set forth above, the defendants acted willfully and with actual malice toward the plaintiff SUSAN O'MALLEY.
- 88. As the result of the publication and the acts of the defendants in connection therewith, the plaintiff has been held up to public contempt, ridiculed, disgraced and prejudiced and has been irreparably injured in her good name and business reputation and has lost the esteem and respect of her colleagues and members of the KCC and CUNY Community.
- 89. As a result of the publication and the acts of the defendants, plaintiff fears that people who know her only through the defendants' false Utterances that she associates with "terrorists" and advocates violence will harm her.

- 90. By reason of the foregoing, the plaintiff has suffered actual and punitive damages in an amount to be determined upon the trial of action.
- 91. The amount of damages sought in this action exceeds the jurisdictional limits of all lower courts which would otherwise have jurisdiction.

### AS AND FOR A FIFTH CAUSE OF ACTION FOR DEFAMATION

- 92. Plaintiff repeats, reiterates and realleges each and every allegation set forth in Paragraphs "1" through "22" and "24" through "52" and "54" through "68" and "70" through "80" and "82" through "91" inclusive, of this complaint, with the same force and effect as though more fully set forth at length herein.
- 93. Commencing on or about Septemer 11, 2007, and continuing to the present day, the defendants published and circulated the following defamatory Utterances of and concerning the plaintiff in their Newsletter, Volume 37, Number 1, a copy of which is attached as Exhibit C, which contains the following matter, to wit:

"It is now OFFICIAL. The Queen is ABSENT from KCC AGAIN this year." and

"The arrogance of being away for four years and immediately requesting a sabbatical at 80% of the top Full Professor salary! But now, after only one year's stint, still with many hours of released time, she is again away at 80% of salary! Plus, most likely, money from the PSC (that's our dues money). How conniving you can be when you are Queen! Obviously, the Queen doesn't like associating with those lowly peasants and serfs, otherwise known as working faculty. Just take the final step already, O'Malley: leave for good!"

- 94. By this publication, the defendant falsely and maliciously charged and was understood by those people reading the Newsletter to charge the plaintiff with being a thief, a person of dishonest and disreputable character, who works for her own selfish interests and against the best interests of the CUNY academic community, who improperly takes monies and or dues from the PSC and uses them for her own benefit, and further a person who dislikes and looks down on her academic colleagues and staff.
- 95. Contrary to the defendants' Utterances, plaintiff SUSAN O'MALLEY has always represented the faculty at KCC and CUNY in an honest manner and has never taken money or received money from the PSC.
- 96. Contrary to the defendants' Utterances, plaintiff SUSAN O'MALLEY has many friends and associates among her fellow faculty and would never call them "lowly peasants and serfs," which term implies that she is superior to them and which implication is false and defamatory.

- 97. At the time the defendants published the defamatory Utterances set forth above, the defendants knew that the Utterances contained both false statements of facts and false implied statements, or recklessly failed to take the proper steps to ascertain the accuracy of the material.
- 98. At the time the defendants published the defamatory Utterances set forth above, the defendants acted willfully and with actual malice toward the plaintiff SUSAN O'MALLEY.
- 99. As the result of the publication and the acts of the defendants in connection therewith, the plaintiff has been held up to public contempt, ridiculed, disgraced and prejudiced and has been irreparably injured in her good name and business reputation and has lost the esteem and respect of her colleagues and members of the KCC and CUNY Community.
- 100. By reason of the foregoing, the plaintiff has suffered actual and punitive damages in an amount to be determined upon the trial of action.
- 101. The amount of damages sought in this action exceeds the jurisdictional limits of all lower courts which would otherwise have jurisdiction.

### AS AND FOR A SIXTH CAUSE OF ACTION FOR DEFAMATION

- 102. Plaintiff repeats, reiterates and realleges each and every allegation set forth in Paragraphs "1" through "22" and "24" through "52" and "54" through "68" and "70" through "80" and "82" through "91" and "93" through "101" inclusive, of this complaint, with the same force and effect as though more fully set forth at length herein.
- 103. Commencing on or about March 29, 2007, and continuing to the present day, the defendants published and circulated the following defamatory Utterances of and concerning the plaintiff in their Newsletter, Volume 36, Number 2, a copy of which is attached as Exhibit C, which contains the following matter, to wit:
  - "She talks about her 'scholarly merit' but does not bring along her supposed publications. It makes one wonder just how 'scholarly' she really is."
- 104. By this publication, the defendant falsely and maliciously charged and was understood by those people reading the Newsletter to charge the plaintiff with being unscholarly, lacking scholarly excellence, and characterizing her academic achievements dishonestly.
- 105. Contrary to the defendants' implication that SUSAN O'MALLEY's research was not "scholarly," SUSAN O'MALLEY has written and edited books and articles for publication, including by the University of Illinois Press, the University of Delaware Press, Oxford University Press, and SUNY Press, all of which prior to publication were peer reviewed to assure their scholarly merit.

- 106. Contrary to the defendants' implication, plaintiff SUSAN O'MALLEY has presented papers, given lectures and participated in seminars at conferences sponsored by the Shakespeare Association of America, the Group for Early Modern Cultural Studies, the Modern Language Association, Attending to Early Modern Women, the Society for the Study of Women in the Renaissance, the English Forum at the CUNY Graduate School, Princeton University, and the International Conference on Higher Education in Ankara, Turkey, Columbia University, and the CUNY Graduate School.
- 107. Contrary to the defendants' Utterances, plaintiff SUSAN O'MALLEY was appointed to the Liberal Studies Program at the CUNY Graduate Center, which is an indication of CUNY's respect for SUSAN O'MALLEY's scholarship and teaching.
- 108. At the time the defendants published the defamatory Utterances set forth above, the defendants knew that the Utterances contained both false statements of facts and false implied statements, or recklessly failed to take the proper steps to ascertain the accuracy of the material.
- 109. At the time the defendants published the defamatory Utterances set forth above, the defendants acted willfully and with actual malice toward the plaintiff SUSAN O'MALLEY.
- 110. As the result of the publication and the acts of the defendants in connection therewith, the plaintiff has been held up to public contempt, ridiculed, disgraced and prejudiced and has been irreparably injured in her good name and business reputation and has lost the esteem and respect of her colleagues and members of the KCC and CUNY Community.
- 111. By reason of the foregoing, the plaintiff has suffered actual and punitive damages in an amount to be determined upon the trial of action.

"CUNY's Queen Abdicates!

The University Faculty Senate breathes A SIGH OF RELIEF!!

Professor Susan O'Malley, longtime member of the English Department at Kingsborough Community College and a former editor of/contributor to the Radical Teacher, has returned, kicking and screaming, to her teaching position after four years as chair of the University Faculty Senate. Many considered her service there to be embarrassing, unproductive and harmful to the university. Long-suffering members of the UFS' staff were so delighted that--according to some reports--they threw a party in celebration of her departure at an undisclosed location in Chelsea. Numerous senators were so overjoyed that they, too, gathered at a watering hole in the Garment District and celebrated with a toast, or so rumor has it."

and

### "THE RETURN OF THE QUEEN?

Prior to her elevation to the Senate, the Queen was seldom seen on her home campus. She was far too busy politicking for more released time."

and

"She considered demonstrating in front of Chancellor Goldstein's residence or conducting a candlelight vigil at KCC President Regina Peruggi's house."

By this publication, the defendant falsely and maliciously charged and was understood by those people reading the Newsletter to charge the plaintiff with being a person of lazy and disreputable character and who was working for her own selfish interests and against the best interests of the academic community for KCC and CUNY, that she dislikes teaching, mistrusts her staff and colleagues, and is in all respects a person who has failed to contribute anything of value to her students, CUNY governance and the CUNY academic community.
- 116. Contrary to the defendants' Utterances, SUSAN O'MALLEY had a distinguished career as a scholar and teacher, and has made outstanding contributions to university governance and to the Faculty Staff Union.
- 117. Contrary to the defendants' Utterances, during her term as Chair of the Faculty Senate, SUSAN O'MALLEY has acquired and retained a high standing and reputation among the CUNY academic community for her advocacy of high academic standards and accessibility of higher education, her humanity and intelligence.
- 118. Contrary to the defendants' Utterances, SUSAN O'MALLEY has always conducted her professional duties with dignity and grace, and her service as UFS Chair has been distinguished and productive.
- 119. Contrary to the defendants' Utterances, SUSAN O'MALLEY was honored with the Resolution of the Executive Committee of the Faculty Senate honoring her service and diligent work, her humanity and intelligence and acclaiming her as a worthy and eminent leader emerita.

- 120. Contrary to the defendants' Utterances, the term of the UFS Chair is limited to four years, SUSAN O'MALLEY served her full term as UFS Chair, and she did not "abdicate" her position.
- 121. Contrary to the defendants' Utterances, SUSAN O'MALLEY likes and enjoys teaching and in fact, defines herself as a teacher as well as a scholar. During her four years as UFS Chair, she missed her students, and the classes she taught upon her return to teaching at KCC were rewarding and valued.
- 122. Contrary to the defendants' Utterances, the only party was held by SUSAN O'MALLEY and the UFS Senators and staff to celebrate her four years as Chair of the UFS.
- 123. Contrary to the defendants' Utterances, during her term as UFS Chair SUSAN O'MALLEY's primary workplace was at the CUNY Central Office, located on E. 80th St., New York, but in addition, she attended various administrative functions at KCC.
- 124. Contrary to the defendants' Utterances, during her term as UFS Chair SUSAN O'MALLEY worked a minimum of 5 days per week, 8 hours per day, and often worked into the evening, on weekends and during the summer.
- 125. Contrary to the defendants' Utterances, the UFS Chair is automatically reassigned from teaching to working full-time at the UFS Office in CUNY's Central Office, and such reassignment is approved by the Chancellor.
- 126. Contrary to the defendants' Utterances, SUSAN O'MALLEY never politicked to be reassigned from her teaching duties.
- 127. Contrary to the defendants' Utterances, SUSAN O'MALLEY has never demonstrated or conducted a candlelight vigil at the KCC's President Regina Peruggi's home.
- 128. Contrary to the defendants' Utterances, SUSAN O'MALLEY has never discussed demonstrating or conducting a candlelight vigil at the KCC President Regina Peruggi's home.
- 129. At the time the defendants published the defamatory Utterances set forth above, the defendants knew that the Utterances contained both false statements of facts and false implied statements, or recklessly failed to take the proper steps to ascertain the accuracy of the material.
- 130. At the time the defendants published the defamatory Utterances set forth above, the defendants acted willfully and with actual malice toward the plaintiff SUSAN O'MALLEY.
- 131. As the result of the publication and the acts of the defendants in connection therewith, the plaintiff has been held up to public contempt, ridiculed, disgraced and prejudiced and has been irreparably injured in her good name and business reputation and has lost the esteem and respect of her colleagues and members of the KCC and CUNY Community.

# "IF YOU VOTE FOR THE "NO/ACTION" SLATE THIS IS WHAT YOU CAN EXPECT"

You will be required:...To participate in a candlelight vigil in front of President Peruggi's home. (After all, the New Caucus' Bowen/London did it in front of Chancellor Goldstein's home. Why not Lloyd/O'Malley in front of Peruggi's home?)"

- 136. By this publication, the defendant falsely and maliciously charged and was understood by those people reading the Newsletter to charge the plaintiff with being a person of disreputable character, who participated in a demonstration in front of Chancellor Goldstein's home and who advocated demonstrations of no value or merit for her own interest and against the best interest of the CUNY academic community.
- 137. At the time the Utterance was published, plaintiff SUSAN O'MALLEY did not know the location of President Peruggi's home.
- 138 Plaintiff SUSAN O'MALLEY has never discussed demonstrating in front of President Peruggi's home.
- 139. At the time the defendants published the defamatory Utterances set forth above, the defendants knew that the Utterances contained both false statements of facts and false implied statements, or recklessly failed to take the proper steps to ascertain the accuracy of the material.
- 140. At the time the defendants published the defamatory Utterances set forth above, the

defendants acted willfully and with actual malice toward the plaintiff SUSAN O'MALLEY.

- 141. As the result of the publication and the acts of the defendants in connection therewith, the plaintiff has been held up to public contempt, ridiculed, disgraced and prejudiced and has been irreparably injured in her good name and business reputation and has lost the esteem and respect of her colleagues and members of the KCC and CUNY Community.
- 142. By reason of the foregoing, the plaintiff has suffered actual and punitive damages in an amount to be determined upon the trial of action.

Plaintiff repeats, reiterates and realleges each and every allegation set forth in Paragraphs "1" through "22" and "24" through "52" and "54" through "68" and "70" through "80" and "82" through "91" and "93" through "101" and "103" through "112" and "114" through "133" and "135" through "143" inclusive, of this complaint, with the same force and effect as though more fully set forth at length herein.
- 145. Commencing on or about April 9, 2007, and continuing to the present day, the defendants published and circulated the following defamatory Utterances of and concerning the plaintiff in their Newsletter, Volume 36, Number 3, a copy of which is attached as Exhibit C, which contains the following matter, to wit:
  - "...of course, she's been AWOL [from KCC] for years!" and

Know that the Queen of Released Time is running for this election not to serve you and the needs of KCC faculty, but for her own selfish interest."

and

- "...[Susan O'Malley attended] a demonstration in front of Senator Joe Lieberman's Connecticut home last Easter Sunday, to oppose his support for fighting terrorists" and
- "ON YOUR DUES MONEY."
- 146. By this publication, the defendant falsely and maliciously charged and was understood by those people reading the Newsletter to charge the plaintiff with being a person of vicious, disreputable character, who works for her own selfish interests, and against the best interest of the CUNY academic community, who is of lazy, selfish and disreputable character, who supports the activities of "terrorists", and opposes those who fight "terrorists", that she is a thief and is only interested in avoiding teaching.

- 147. Contrary to the defendants' Utterances that SUSAN O'MALLEY has been AWOL from the KCC for years, SUSAN O'MALLEY was elected and served from 2002-2006 as the Chair of the UFS (the first Community College Professor to do so), attended College Counsel meetings at KCC, served as the representative for KCC and attended numerous committee meetings at KCC, all in service for and at KCC.
- 148. Contrary to the defendants' Utterances, SUSAN O'MALLEY never attended a demonstration in front of Senator Joe Lieberman's Connecticut home to oppose his support for fighting "terrorists" or for any other reason.
- 149. Contrary to the defendants' Utterances, plaintiff SUSAN O'MALLEY has never received reassigned time from the current PSC leadership.
- 150. At the time the defendants published the defamatory Utterances set forth above, the defendants knew that the Utterances contained both false statements of facts and false implied statements, or recklessly failed to take the proper steps to ascertain the accuracy of the material.
- 151. At the time the defendants published the defamatory Utterances set forth above, the defendants acted willfully and with actual malice toward the plaintiff SUSAN O'MALLEY.
- 152. As the result of the publication and the acts of the defendants in connection therewith, the plaintiff has been held up to public contempt, ridiculed, disgraced and prejudiced and has been irreparably injured in her good name and business reputation and has lost the esteem and respect of her colleagues and members of the KCC and CUNY Community.
- 153. By reason of the foregoing, the plaintiff has suffered actual and punitive damages in an amount to be determined upon the trial of action.

# AS AND FOR A TENTH CAUSE OF ACTION FOR INTENTIONAL INFLICTION OF EMOTIONAL DISTRESS

- 155. Plaintiff repeats, reiterates and realleges each and every allegation set forth in Paragraphs "1" through "22" and "24" through "52" and "54" through "68" and "70" through "80" and "82" through "91" and "93" through "101" and "103" through "112" and "114" through "133" and "135 through "143" and "145" through "154" inclusive, of this complaint, with the same force and effect as though more fully set forth at length herein.
- 156. As a result of the defendants' false and hurtful Utterances in the Newsletter, on or about the dates set forth above, plaintiff has sustained severe mental and emotional anguish and distress.

- 157. The defendants outrageously intended to cause or recklessly caused plaintiff mental or emotional distress, mental anguish, and fear for her personal safety.
- 158. Defendants in inflicting severe mental and emotional distress upon SUSAN O'MALLEY, at all times acted willfully and with actual malice toward plaintiff SUSAN O'MALLEY.
- 160. By reason of the foregoing, the plaintiff has suffered actual and punitive damages in an amount to be determined upon the trial of action.
- 161. The amount of damages sought in this action exceeds the jurisdictional limits of all lower courts which would otherwise have jurisdiction.

WHEREFORE, the plaintiff, SUSAN O'MALLEY, demands judgment against the defendants as follows:

- A. On the First, Second, Third, Fourth, Fifth, Sixth, Seventh, Eighth, Ninth and Tenth Causes of Action, awarding plaintiff SUSAN O'MALLEY actual and punitive damages in an amount to be determined upon the trial of this action;
- B. For an Order permanently enjoining the defendants from making any oral or written communication to any person, other than their attorneys, that suggest the plaintiff has committed unlawful acts or crimes, or that could foreseeably impugn the plaintiff's character, integrity or reputation in the opinion of an ordinary person;
- C. For an Order that all pleadings, papers, exhibits and other matter filed with the Court in this action be sealed;
- D. For an Order directing the defendants to publically apologize for their defamatory Utterances and to publish retractions of same;
- E. Awarding plaintiff SUSAN O'MALLEY her costs, and disbursements in this action; and
- F. Granting the plaintiff SUSAN O'MALLEY such other and further relief as to this Court may seem just and proper.

Please be advised that this office represents Professor Susan O'Malley with respect to the above matter.

We have reviewed the publication entitled "The Patriot Returns," Vol. 35, No. 4, March 12, 2007, which has been sent via email to members of the faculty, staff, and administration of Kingsborough Community College; members of the CUNY faculty and staff throughout the University; the Chancellery; and the Board of Trustees.

The publication contains several false, damaging, and defamatory statements regarding Professor O'Malley including the following:

- 1. That she is obsessed with finding jobs for terrorists and, in particular, for Mohammed Yousry



This is the letter that I sent to the Daily News last night. I do not know if it will be published.

I have always been proud that one of the goals of the U.S. criminal justice system is rehabilitation. A person who has served time for a crime is supposed to be integrated back into society after being released from jail. Unfortunately this has not been the case for Professor Susan Rosenberg. A writer herself, Rosenberg has team taught a course on prison writing at John Jay College of Criminal Justice/CUNY over the last four years. She has never hidden the fact of her felony conviction. Because of complaints to Jeremy Travis, John Jay's impressive new president, by the Police Emerald Society, which objects to Rosenberg's association with people convicted for the 1981 Rockland County Brinks robbery - she herself was never tried for that crime - Rosenberg is not being allowed to teach again at John Jay College. Rosenberg did, in fact, serve 18 years for the possession of a large quantity of explosives and guns in her apartment discovered 23 years ago. She has been evaluated satisfactorily by her department which had planned for her to teach next fall. This action by the John Jay president is particularly ironic as President Travis is a renowned expert on the re-entry of prisoners into society. Decisions as to who should be teaching at a college should not be based on the wishes of groups external to the college.

# MOHAMMED ON HER MIND! O'MALLEY'S OBSESSION WITH FINDING JOBS FOR TERRORISTS

It's almost unbelievable, but sending e-mails to the Senate Forum was not enough. To which Professor Beaky of LaGuardia responded "I don't think I have

an answer to that question. Others may. As you may or may not know he's been sentenced to 20 months and that is under appeal at the present time."

Thereupon UFS Chair Philip politely cut-off the discussion by saying, "Thank you, Lenore, for your very interesting report. The next item on our agenda is..."

Yes, yes, Mohammed was on her mind and she was not going to rest until she got this convicted terrorist a job. We do not know how many people she buttonholed, or telephoned, or e-mailed for him. But we sure do know that she used her position as a former Chair of the UFS to be recognized at the plemary and sneak in this "Job Wanted for the terrorist" ad. She even made sure to notify the delegates that she had his telephone number and could contact him.

#### Our questions are:

- 1) Has Queen O'Malley ever made a "Job Wanted" announcement like this for a non-convicted, non-violent, peace loving American educator for a job in CUNY? There are hundreds of qualified people looking for teaching jobs. Why does she prefer convicted terrorists who are bent on harming our people and our nation, over peace-loving Americans?
- 2) During her six year tenure as the Chair of the UFS, did she ever give UFS delegates an opportunity to make announcements of this nature? If not, why not?
- 3) Being on the PSC's Executive Committee, she knew that Yousry, fired from his adjunct position at York in April 2002, was provided with all legal and contractual protection from "step one", all the way up to arbitration (AAA Case no. 13-390-00960-03.Arbitrator: Alan A. Symonette. Decision date Jan. 16, 2004.), which cost thousand of dollars, money which came from dues paying members. She knew that in Arbitration, Yousry lost big. In the process, the PSC lost a longstanding timely-notification privilege that had been enjoyed by thousands of adjuncts for many, many years. One had to be really stupid to think that the CUNY administration was going to roll out a welcome mat in CUNY for this terrorist and put him back on the payroll after his conviction in Federal Court and after CUNY prevailed in arbitration.

We believe that O'Malley was so obsessed with putting Mohammed back on the CUNY payroll, that it pretty much confirms what we said in our earlier Patriot Returns (Issue 35.3), i.e., that she is recruiting naïve, innocent members of the KCC faculty into her Queda-Camp, to infiltrate college and departmental Personnel and Budget Committees in her mission — to recruit terrorists in CUNY. 

### CAN SHIE BE TRUSTED TO COUNT THE BALLOTS CORRECTLY?

The chapter elections currently in progress have been conducted by the PSC in a totally incompetent fashion. Or in a deliberately dishonest fashion. You decide.

There are 3 contested chapter elections this year, and there have been serious errors made on printed ballots sent to members' homes in each of those elections. Curiously, the New-Caucus controlled elections committee made these "mistakes" only on ballot information for slates opposing Bowen's New Caucus group.

At BMCC, the slate name of BMCC FACULTY SLATE was incorrect on the ballot (appearing instead as "BMCC Caucus Slate", designed to confuse the voters?)

For the HEOs, the HEOS NOW SLATE appears on the ballot as the NOW SLATE (also designed to confuse).

At KCC, a member of the non-New Caucus YOUR FACULTY SLATE was omitted from the ballot, and another person's name repeated instead.

How hard is it to copy a short list of words and names, anyway!? The PSC has been conducting Chapter and General elections every year since its inception - for over thirty years! By this time, they should know the mechanics of conducting an election by heart! The PSC gives the final copies of slate and candidate names to the American Arbitration Association for printing. We believe that before printing, the AAA must send final copy back to the PSC for proof reading for accuracy. Unless the PSC submits wrong information to the AAA, these types of errors do not occur.

How could this happen? Shouldn't the blame rightly be placed on the doorsteps of Bowen and London? Are these mot Bowen's dirty tricks? Is this happening because several chapters have candidates opposing Bowen's New Caucus candidates?

Of course, Bowen and London might blame it all on Election Committee Chair Frank Deale of CUNY Law School. But it's more likely they'll blame the "staff" or a secretary. The staff members depend on Bowen for their jobs, so they'll be forced - like hostages in Iran - to say that they are guilty. But THREE MAJOR ERRORS - and NONE for New Caucus slates!???? Come on! O'MALLEY TO SEEK CUNY JOB OPPORTUNITIES FOR LYNN STEWART'S DAUGHTER ACCUSED OF FAKING SICK LEAVE

It has been rumored in CUNY circles that Susan O'Malley, Community College officer on the PSC Executive Committee was in contact with Brenna Stewart, 45 year old daughter of Lynn Stewart, long before the news hit the papers on April 12th that Brenna has been accused of faking sick days and is about to be fired from her job as a gym teacher in a Bronx high school. According to the Daily News, from October 2005 to January 2007, Brenna submitted "false notes" for eight absences "including one in which she altered the date on her aunt's death certificate so that she could take a bereavement day three years after the woman actually passed away." Unconfirmed reports indicate that O'Malley has obtained Brenna's resume and made copies for distribution at the next Delegate Assembly. Similar to the appeal she made for terrorists Mohammed Yousry and Susan Rosenberg (The Patriot Returns Vol. 35, no. 3 and The Patriot Returns Vol.35 no. 4,) she plans again to use her PSC position to make a personal appeal to the DA to alert members to her wish for a job for Brenna in one of the CUNY units. Richard Condon, the school's investigator, has called Brenna's alleged crime "fraud and larceny" and has recommended that she be fired. But according to our sources, O'Malley intends to find a lucrative job for Brenna at CUNY. College Presidents, Department Chairs, be on the lookout. Brenna will be on your campus this summer, courtesy of the Queen of Released time, and you may be singled out as O'Malley's patsy.

### DUES INCREASES?

In the inner circle of the Bowen/London camp at PSC offices, there are hush hush, but serious discussions about the appropriate timing and the amount of soon-to-be-increased dues. Although the PSC in its Demand #29 asked for 250 additional released time hours for themselves (equivalent to 9 to 12 full-paid positions!), and although the cost of these positions comes out of members' potential salary increases, they think even this is not enough. Increasing membership dues so they can buy even more released time is easier. They can get it approved by a spineless, rubber-stamp Delegate Assembly faster than through negotiations.

### WHAT BARBARA REALLY WANTS THE HIDDEN DEMIANDS!

Demand No. 11A) Reassigned Time: All members of the instructional staff shall receive substantial time to engage in discussion pertaining to world issues, especially polygamy, monogamy, boycott of chocolate and asparagus, etc. organized by Jim Perlstein, Chair of the Peace and "My-Idea-Of-" Justice Committee. The cost of this time will be deducted from instructional staff salaries.

Demand No. 21A) Pet Medical Leave: Employees will be allowed 15 days a year to take care of their domestic pets' illnesses, and other emergencies. The cost of funding these leave days will be deducted from projected instructional staff salaries.

Demand No. 21B) Pet Care: While dogs and cats are generally already cared for, this provision will require colleges to establish, on each campus, a licensed Pet Care Center for the use of heretofore unrecognized pets, including sparrows, pigeons, snakes and rodents. Colleges will provide 10 minutes of "Petting Break" every three hours for faculty with pets in the Pet Care Center. The cost of maintaining these facilities will be deducted from already-pitiful projected instructional staff salaries.

Demand No. 31A) Yet More Reassigned Time for Union Officers. This time will be exclusively designated for protests, marches and vigils at the residences of the Chancellor and College Presidents, and for marches in support of such venerated celebrities as Hugo Chavez and Osama Bin Laden. The cost of this time will be deducted from already-pitiful instructional staff salaries.

### SHAMIE! SHAMIE! SHAMIE! COMMONER IDEFEATS THE QUEEN!





### O'MAILIEY ATTACKS DECEASED COLLEGE PRESIDENT

The following paragraph, authored by Queen of Released Time Susan O'Malley, appeared in "Single Parenting Maneuvers In Academia" in the periodical *Radical Teacher*, vol. 57, copyright date Fall 1999, page 31. The paragraph refers to her maneuvering to get tenure at Kingsborough Community College, and what she did to impress President Goldstein. The Queen writes:

Next the union arranged a meeting for me with President Goldstein. I debated long and hard about my next step, which my feminist sister said was disgusting, but I decided to go ahead. I was desperate. I got dressed up to look as attractive and feminine as possible and arrived at President Goldstein's office on the appointed hour holding the hands of my two small, beautiful, tow-headed children who looked rather waif-like, as they were dressed to go to the beach. Their friend Susan, whose father knew President Goldstein, also came along. When he opened the door, I smiled graciously and said, "There has never been a question about my scholarly merit, but I wanted to make sure that you knew I am sole support of these children." Much to President Goldstein's credit, he decided instantaneously to work a deal with the union for my tenure, but not before he said, "I want to tell you that no matter what happens about tenure, you are a very lovely woman," and I graciously said, "Thank you so much, but I do want tenure," instead of "Up yours! What does my appearance have to do with this" It is ironic that . . . it was the fact of the children and my being a single mother . . . , that caused

President Goldstein to relent. And so I was granted tenure . . . (emphasis supplied)

The above paragraph of necessity leads one to make the following observations.

- 1) That Susan O'Malley will put on different faces to different people to achieve her goals. Can we ever take her words for what they are?
- 2) She dresses up nicely and brings her kids to gain *pity*. Well, who can blame President Goldstein for trying to be nice and give her an innocent compliment?
- 3) She has no qualms about using her children as pawns to advance her claim for a job that she may or may not have been qualified to have. (We are reluctant to reference anyone's family member especially children here at the Patriot, however, in this instance, we have no choice.)
- 4) She talks about her "scholarly merit" but does not bring along her supposed publications. It makes one wonder just how "scholarly" she really is.

One must conclude that the Queen of Released Time is nothing but a hypocrite; a double talking, self-serving, opportunist who will bite the hands of those who feed her, sell out her own values just to get ahead. It was she who dressed up to look attractive, it was she who brought her two children with her to get sympathy, and when the president (presumably and innocently) made an offhand complimentary remark, she attacked him.

### CUNY's Queen Abdicates!



### The University Faculty Senate breathes A SIGH OF RELUEF!!

Professor Susan O'Malley, longtime member of the English Department at Kingsborough Community College and a former editor of/contributor to the *Radical Teacher*, has returned, kicking and screaming, to her teaching position after four years as chair of the University Faculty Senate. Many considered her service there to be embarrassing, unproductive and harmful to the university. Long-suffering members of the UFS' staff were so delighted that—according to some reports—they threw a party in celebration of her departure at an undisclosed location in Chelsea. Numerous

senators were so overjoyed that they, too, gathered at a watering hole in the Garment District and celebrated with a toast, or so rumor has it. Over the years, Smilin' Susan embroiled the Senate in issues of no import mor interest, save to her and her ideological buddies. Both staff and senators realize that the end of Susan's reign of errors marks the beginning of era in which the UFS may again make positive, substantive contributions toward improving CUNY.

As a non-voting member of the Board of Trustees, the Queen of Released time was a regular presence at plenary and committee meetings. But with the end of her senatorial perquisites, Smilin' Susan faced the grim prospect of teaching English to undergraduates. Again she began angling for ways to avoid work. Though an opportunity arose to become Department Chair, she had scant support among her colleagues. Susan needed to think fast!

Now sabbaticals are a good way to get away from the quotidian tasks of teaching. So, Susan applied research leave, with a rumored project on "Assessing My Experience as an Academic Leader." She was quite confident that no one at the college would dare deny sabbatical leave to a VIFSC (Very Important Former Semate Chair).

Susan's delusions of grandeur began to dissipate, however when Kingsborough's P&B Committee turned down the sabbatical request.

What a disappointment for our Queen! On April 8th she fired out an angry interrogatory to the Senate Forum: "Have sabbaticals been denied on your campus for next year? ... My two spring sabbatical at half pay or possibly 80 percent pay was [sic] denied..."

Sadly, only a few of her former subjects deigned to reply. Susan gave some thought filing a grievance, but soon discovered that a sabbatical denial was not grieveable. She considered demonstrating in from of Chancellor Goldstein's residence or conducting a candlelight vigil at KCC President Regina Peruggi's house. But we've heard that even Barbara Bowen, her favorite protestor-in-arms, would not join in such a piqued picketing.

### EXIERCISING SIENATORIAL IPREROGRATUVE

But not to worry. Even at public universities power has its privileges. The UFS, to whom the University grants reassigned time for presumably important work, has in the past rewarded outgoing chairs with released time. It seems that Susan's designated herself 6 to 8 hours of annual released time for the next few years. In addition, the Dear Leader Barbara Bowen may be doling out additional released time in return for harassing the Chancelfor and Bolf Chairman Schmidt. This should enable her to earn a full salary without carrying a full, 27-hour teaching load for yet another few years! Tho' she won't be chair, nor on sabbatical, she won't be covered in chalk dust, either.

### BUT DOWN AT KCC, LIFE'S A BEACH

Yet, how do we know that she will not shortchange KCC's students? In an effort to protect their right to a good education, we politely recommend that the college's administrators take the following steps:

- In an effort to prevent Professor O'Malley from getting lost or missing class, a knowledgeable security officer should be assigned to reacquaint her with the campus. Special care should be taken around access points to the Atlantic Ocean.
- · A junior member of the English Department should be assigned

- to mentor her, and make her feel comfortable in her new surroundings. Special attention should be devoted to how to deliver lectures, write exams, and relate to students.
- o The chair should regularly send observers to Susan's classroom, to provide remediation in blackboard manners and question and answer techniques. Follow-up meetings with the chair should be scheduled, at which teaching-related traumas can be dealt with.

### AVE ATQUE VALLE?

Our advice to the Queen, however, is more succinct: it is time to go! Most members of KCC's militant sisterhood, such as "Lady Chattery" Chase and Eva (the Duchess of Park Slope) Richter, have left the lecture halls in favor of senior centers. You should, too. 


