25 ***Plaintiff, upon information and belief, hereby alleges as follows:***

- 26 1. Plaintiff is a resident of Murrieta, California.
- 27 2. Defendant About Murrieta Blog "hereinafter referred to as MURRIETA BLOG"
28 is an association or business of unknown form that operates from Murrieta,
California.
3. Defendant Murrietaopinion.blogspot.com "hereinafter referred to as MURRIETA
OPINION" is an association or business of unknown form that operates from
Murrieta, California.
4. All of the statements or acts, upon which this action is based, were made or

- 1 conducted within the boundaries of this Court's jurisdiction.
- 2 5. DOES 1 through 20 are the operators or bloggers of the other Defendants and are
3 directly responsible for the harms and damages alleged herein. Each such
4 defendant is unknown to the Plaintiff at this time because the defendants hide
5 behind the veil of the Internet to cover up their nefarious and tortious activities.
6 Once the true identities of these persons are uncovered, Plaintiff will amend this
7 complaint accordingly.
- 8 6. Each of the defendants are working with the other in some capacity and are jointly
9 and/or severally liable in whole or part for the damages alleged herein.

10 **FIRST CAUSE OF ACTION**
11 **FOR DEFAMATION**

- 12 7. Plaintiff hereby incorporates Paragraphs 1 through 6 as though fully set forth and
13 alleged herein.
- 14 8. Within the last calendar year, the Defendants caused false statements to be
15 published on the Internet of and concerning the Plaintiff. MURRIETA BLOG and
16 MURRIETA OPINION both have caused to be published the false material
17 referenced in this complaint and have conspired to do the same.
- 18 9. The false statements, which are contained in Exhibit "1," include, but are not
19 limited to the following factually false statements or general assertions:
- 20 a. That Plaintiff is a stalker. Stalking is a crime in California and this
21 statement is defamatory per se'.
 - 22 b. That Plaintiff has "threatened" or engage in personal "threats" against the
23 author of the defamatory material on MURRIETA OPINION.
 - 24 c. That Plaintiff is married to an illegal alien.
 - 25 d. That Plaintiff has committed crimes concerning the destruction of
26 personal/real property. This material is defamatory per se'.
 - 27 e. That the Murrieta Police have somehow documented alleged criminal
28 activity by Plaintiff. Plaintiff has spoken with the Murrieta Police

1 Department and cannot find any complaints against him. Again, the
2 statements by Defendants suggest criminal conduct on the part of the
3 Plaintiff and such statements are defamatory per se'.

4 f. That Plaintiff somehow stole intellectual property belonging to someone
5 associated with Defendants.

6 g. That Plaintiff engaged in an illegal invasion of privacy against Defendants.

7 h. That Plaintiff has illegally gained credit report information on Defendants
8 or persons close to them.

9 i. That Plaintiff may have been involved in vandalizing a sports utility
10 vehicle belonging to a DOE Defendant using the moniker "Jeff" on
11 MURRIETA OPINION.

12 j. That Plaintiff had "an insane, sick obsession to attack and hurt members of
13 Rescue Murrieta."

14 k. That Plaintiff begs for money on the side of the road.

15 l. That Plaintiff was "cheating with a blog owner."

16 10. The person identified as "voteoutrepublicans" on MURRIETA OPINION is DOE
17 1 as referenced herein. The statements made by DOE 1 as to Plaintiff being a
18 "danger to this community" and "Roy is truly very dangerous to his neighbors. If
19 he finds a bloggers name he will try to do as much damage to the person, both on
20 the blog and literally contacting you and trying to hurt your property. He has
21 mental problems and emotional problems he can't control" are false and
22 defamatory.

23 11. The above referenced statements are alleged to be of a factual nature and are not
24 privileged or otherwise protected by the First Amendment.

25 12. The statements made by Defendants have invaded the legitimate interests of the
26 Plaintiff in maintain his reputation in the community.

27 13. The statements made by the Defendants are false and unprivileged.

28 14. The statements referenced above and contained in Exhibit "1" are in writing, as

- 1 defined by law, and have exposed Plaintiff to hatred, ridicule, contempt, and
2 disgrace and have injured Plaintiff in his business dealings.
- 3 15. The statements charge Plaintiff with crimes that he never committed or would
4 commit.
- 5 16. The statements injure Plaintiff in his trade, business, profession or livelihood and
6 are intended by the Defendants to do so.
- 7 17. The statements referenced in Exhibit "1," where not otherwise protected by the
8 First Amendment (i.e., opinions, political speech, etc.), by their natural
9 consequence, did actually cause damages to Plaintiff as a matter of law.
- 10 18. This suit relates only to the speech of the Defendants which is factually false,
11 injurious to reputation as a matter of law, and which is defamatory.
- 12 19. Certain opinions of the Defendants as referenced above conveyed a provably false
13 assertion of fact or facts with respect to alleged crimes, mental health, business
14 dealings, and of and concerning Plaintiff's wife.
- 15 20. The average reader of the statements concerning stalking and other alleged
16 criminal conduct would regard the statements as being defamatory.
- 17 21. The statements referenced above have been published as a matter of law.
- 18 22. The publication of these materials was intentional in that the Defendants knew or
19 should have known that the matter was false, in reckless disregard of known facts,
20 or with the simple intention of harming Plaintiff.
- 21 23. All persons reading the defamatory statements know that such statements refer
22 directly to Plaintiff.
- 23 24. Plaintiff is not a public figure and has never cast himself into any position
24 whereby he is in the public light.
- 25 25. Defendants made no reasonable attempt to confirm or deny the horrific statements
26 made of and concerning Plaintiff as alleged herein.
- 27 26. Defendants did not have a good faith belief in the truth of any of the factual
28 averments made by them and published as alleged herein.

- 1 27. Defendants are not television, radio, or newspaper defendants within the meaning
2 of California law.
- 3 28. Plaintiff has suffered both general and special damages as a result of the actions
4 of the Defendants as referenced herein.
- 5 29. Plaintiff has suffered loss of his good name, reputation, and respect within the
6 community as a result of the egregious conduct of the Defendants.
- 7 30. Defendants will continue to post false information concerning Plaintiff unless
8 stopped by this Court.
- 9 31. Damages continue to be sustained by Plaintiff by the day as a result of the
10 continual posting of false and defamatory statements about him.
- 11 32. The conduct of the Defendants was fraudulent, oppressive, malicious, and
12 intended to suppress the rights of Plaintiff. As such, punitive damages should and
13 must be assessed the responsible defendants. Plaintiff seeks up to and including
14 1/3 of the net worth of each of the Defendants in amounts to be proven the trial of
15 this matter.

16 **PRAYER**

17 WHEREFOR, Plaintiff prays for relief as follows:

- 18 1. For special damages in an amount to be proven at time of trial.
- 19 2. For general damages of not less than \$25,000.00.
- 20 3. For injunctive relief aimed at the removal of false information being
21 published by Defendants on the Internet.
- 22 4. For out of pocket costs associated with the filing of this suit.
- 23 5. For costs of suit.
- 24 6. For punitive damages in an amount sufficient to deter the Defendants from
25 intentionally or recklessly publishing false statements of alleged fact of and
26 concerning the Plaintiff.
- 27 7. For any and all other relief as may be deemed appropriate to make Plaintiff
28 whole for his losses.

SATURDAY, FEBRUARY 23, 2008

I believe there is both worth and glory in the achievement of individuals. However, I do not believe in the elevation of selfishness into a virtue. What I want sometimes comes -- as it rightfully should -- behind what

many others need.

I believe that noble self-sacrifice is not something that is demanded of only a few on the battlefield. It's something that's demanded of almost everyone, almost every day, in ways both great and small. That includes when I pay my taxes.

I believe that we almost never have the government we need, rarely get the government we deserve, but nearly always have the government we earn. That is, the quality of our government is exactly equal to the effort we're willing to expend. If we are convinced that government is intrinsically evil, or hopelessly corrupt, our neglect will be reflected in bad governance -- and we'll have no one to blame but ourselves.

I believe that the government is not separable from the governed. Pretending that we are governed by some "other" -- be it secret organizations or evil aliens -- is only an excuse to not put in the work needed to make government better. Like it or not, in America there is no line between "us" and "them."

I believe that elections count, that my vote matters, and that all politicians are not created equal. I do not believe in dark cabals or conspiracies that keep the numbers in elections from representing the actual votes cast -- that includes both theories of massive vote fraud and theories of voting machine malfeasance. I do not believe every politician will, once seated in Congress or the White House, instantly transform into a servant of the status quo. Our system, while neither as open or as fair as it should be, is far too open and fair to be controlled like a puppet by a few shadowy figures. Pretending that the outcome of elections is either preordained or pointless is another reason to complain when we should be working to fix things. (oh yeah, I also do not believe in wacky theories about zillion dollar offshore slush funds full of money from ambulance-chasing lawyers that gets fed to thousands of people so they can sneakily insert it into the pockets of pet politicians. Sheesh.)

I believe that government is worth making better, and that Government is not only vital, but also good. There are things that we can achieve as a community -- and it's a large set of things, not a small one -- that we can not achieve as individuals. This includes (but is far from limited to) our mutual defense, public education, the infrastructure on which we all rely, the protection of our individual rights, the protection of workers, and the protection of our environment.

I believe it's within the government's justifiable powers to take some of the taxes collected from those able to pay, and use it for the benefit of those less able. Not just because "as you do to the least of these" is a core tenet of many religions, not just because it's sound moral principle, but because it's absolutely required to generate the kind of society in which

anyone would want to live.

Finally, I believe it is not too late. Not too late to do the right thing in our foreign policy. Not too late to do the right thing with our environmental policies. Not too late to change. And that if we stop blaming the Illuminati for our problems and get out there and vote, we really can take our country back.

Looking at America

There are too many moments these days when we cannot recognize our country. Sunday was one of them, as we read the account in The Times of how men in some of the most trusted posts in the nation plotted to cover up the torture of prisoners by Central Intelligence Agency interrogators by destroying videotapes of their sickening behavior. It was impossible to see the founding principles of the greatest democracy in the contempt these men and their bosses showed for the Constitution, the rule of law and human decency.

It was not the first time in recent years we've felt this horror, this sorrowful sense of estrangement, not nearly. This sort of lawless behavior has become standard practice since Sept. 11, 2001.

The country and much of the world was rightly and profoundly frightened by the single-minded hatred and ingenuity displayed by this new enemy. But there is no excuse for how President Bush and his advisers panicked -- how they forgot that it is their responsibility to protect American lives and American ideals, that there really is no safety for Americans or their country when those ideals are sacrificed.

Out of panic and ideology, President Bush squandered America's position of moral and political leadership, swept aside international institutions and treaties, sullied America's global image, and trampled

on the constitutional pillars that have supported our democracy through the most terrifying and challenging times. These policies have fed the world's anger and alienation and have not made any of us safer.

In the years since 9/11, we have seen American soldiers abuse, sexually humiliate, torment and murder prisoners in Afghanistan and Iraq. A few have been punished, but their leaders have never been called to account. We have seen mercenaries gun down Iraqi civilians with no fear of prosecution. We have seen the president, sworn to defend the Constitution, turn his powers on his own citizens, authorizing the intelligence agencies to spy on Americans, wiretapping phones and intercepting international e-mail messages without a warrant.

We have read accounts of how the government's top lawyers huddled in secret after the attacks in New York and Washington and plotted ways to circumvent the Geneva Conventions — and both American and international law — to hold anyone the president chose indefinitely without charges or judicial review.

Those same lawyers then twisted other laws beyond recognition to allow Mr. Bush to turn intelligence agents into torturers, to force doctors to abdicate their professional oaths and responsibilities to prepare prisoners for abuse, and then to monitor the torment to make sure it didn't go just a bit too far and actually kill them.

The White House used the fear of terrorism and the sense of national unity to ram laws through Congress that gave law-enforcement agencies far more power than they truly needed to respond to the threat — and at the same time fulfilled the imperial fantasies of Vice President Dick Cheney and others determined to use the tragedy of 9/11 to arrogate as much power as they could.

Hundreds of men, swept up on the battlefields of Afghanistan and Iraq, were thrown into a prison in Guantánamo Bay, Cuba, so that the White House could claim they were beyond the reach of American laws. Prisoners are held there with no hope of real justice, only the chance to face a kangaroo court where evidence and the names of their accusers are kept secret, and where they are not permitted to talk about the abuse they have suffered at the hands of American jailers.

In other foreign lands, the C.I.A. set up secret jails where “high-value detainees” were subjected to ever more barbaric acts, including simulated drowning. These crimes were videotaped, so that “experts” could watch them, and then the videotapes were destroyed, after consultation with the White House, in the hope that Americans would never know.

The C.I.A. contracted out its inhumanity to nations with no respect for
