Hi Archie,

I understand the purpose of your website and admire your mission and the effort you have placed into creating your site.

Our business is a simple one of providing employers with free job postings in exchange for placing ads on the job applications. We never spam, never phish, and never sell names of our applicants. If applicants specifically request information from an advertiser they are directed to the advertiser's site and complete a form directly on that site.

Our advertisers are mainly Fortune 500 companies (or provided through third party sites such as Google).

Much of the negative information was initially created by a programmer that was fired about 3 years ago. He posted information alleging that we were phishing etc. Since then people reading his posts have followed suit.

He was talented enough to cause complaints to legitimate media and the BBB etc. The complaints are all based on allegations seen online rather than actual negative experiences by our site users.

After initially ignoring the information and assuming people would not be naive enough to believe anonymous postings, we have finally decided enough is enough and we are addressing all negative information online.

Most of the websites owners contacted have removed the false and defamatory postings willingly. As you are aware we have been forced to file lawsuits against some individuals. As you can see by public record these individuals are attempting to fight the lawsuits by claiming jurisdictional arguments etc. No one has attempted to fight the lawsuit on the merits as the information posted is 100% false.

Additionally we have a policy that once we file a lawsuit we will not settle the matter. We will continue the lawsuit to a jury trial resolution.

Again we would much rather settle this matter amicably and avoid the time and expense of a lawsuit for both parties. To that end I am willing to answer any questions you have about our process to help resolve the situation.

Archie,

I understand that you have the ability and the right to post anything I email to you on your website. Probably the one reason I was correct in not giving you the address of where my child lives (which you may have posted online).

I do appreciate your responding to me promptly to at least attempt to settle this matter. I will give you a preview of what is about to happen.

On Wednesday June 4th we will be filing a lawsuit in Federal Court naming you and anyone on your site that has posted anything negative about us.

You may try to evade service but we will eventually serve you with the lawsuit.

Your first objective will be to try to have the case dismissed. Your best chance to have a dismissal using the millennium act (basically stating that you do not monitor or control the content on the site) has already been ruined as you have stated in our emails your direct involvement on the site.

If you attempt the "public domain" argument you stated in an earlier email you will probably be sanctioned by the judge and advised to retain counsel. The argument protects you against publishing copyrighted material, not libel or slander.

Archie,

I don't understand what "tricks" you are talking about. I have verified that I am a representative of Internet Solutions by giving you a work phone and a work email address. You have been sent a letter by a lawyer representing Internet Solutions. You can easily look up that Keith Kress is in fact a lawyer licensed in Florida.

I have told you repeatedly that our organization has not engaged in any deceptive practices or phishing. I have asked you to show any evidence of such activity (other than hearsay posted online). However if it will make you happy I will give you my assurance that our company will not engage in any deceptive, illegal, or immoral practices including but not limited to data phishing, and any other form of illegal data mining.

Since you have been watching our company for years you are no doubt aware that any website posting the same false information about us falls under one of four categories:

1. They are in hiding, talking great length to veil their identity.
2. In most cases they have removed negative information
3. They are currently in litigation
4. They are about to be in litigation.

It is public record that we have sued several individuals. If the information posted on your site and other were true the last thing we would do is call attention to ourselves by bringing the matter to court.
