SUPPLEMENTAL FILING

Complainants respectfully request that the Panel exercise its discretion and consider this supplemental filing in response to Respondent's Response to the Amended Complaint ("Response"). The Response raises numerous legal and factual inaccuracies that could result in a misleading record for the Panel if such inaccuracies are not addressed.

A. The Instant URDP Claim is Based on Trademark Law; Thus, Respondent's First Amendment Arguments Should Be Rejected

Respondent goes on at great length in his Response about the First Amendment and how Complainants seek to quash Respondent's free speech rights. However, just because Respondent claims that the maliciously and intentionally horrific domain name of his website is an exercise in free speech trademark parody, does not mean that it is. Even if parody analysis is to be applied to Respondent's domain name's unqualified and knowingly false association of Glenn Beck with the horrific crimes of rape and murder, as noted by Professor McCarthy in his treatise *McCarthy on Trademarks*:

[T]he cry of "parody!" does not magically fend off otherwise legitimate claims of trademark infringement or dilution. There are confusing parodies and non-confusing parodies. All they have in common is an attempt at humor through the use of someone else's trademark. A non-infringing parody is merely amusing, not confusing.

McCarthy on Trademarks, § 31:153, at 31-262. Similarly, as this Panel explained in *Sutherland Institute v. Continuitive LLC*, WIPO Case No. D2009-0693:

In the traditional copyright defense, the copyright “parodist” has drawn the reader, viewer or listener to his or her work by first appearing to be the original, and then changing direction to make fun of or criticize the original. It is important to a parody defense that the distinction between the parody and original work ultimately be sufficiently clear. The parodist should not make such extensive use of the original work as to essentially rely on the original for its expressive effect. In other words, the parodist must not merely be re-packaging and selling the original.

While there is absolutely nothing humorous or amusing about the statement made by Respondent in his domain name that “Glenn Beck Raped and Murdered a Young Girl in 1990”, the average internet user finding the domain name GlennBeckRapedAndMurderedAYoungGirlin1990.com (the “Disputed Domain Name”) in a search would have no reason not to believe that they will be directed to a website providing factual information (as opposed to protected criticism or similar protected speech) about Mr. Beck.¹ As discussed in depth below, both Respondent and his counsel even admit that it is not readily apparent from the Disputed Domain Name itself to understand that it is supposed to be a “joke.” Their admission highlights the extent to which the Disputed Domain Name resides outside the boundaries of protected free speech to the same extent as would calling out “Fire” in a crowded room. *See* Section C, *infra*.

While a tension between Trademark Law and the First Amendment is inevitable, the two theories can and do and must co-exist, and the extent of speech protected by First Amendment does not act to bar legitimate trademark infringement and dilution claims, such as Complainants’ here.² *See Sutherland Institute, supra* (“individuals do not enjoy absolute freedom of expression

¹ This seems especially true because the website previously featured a “Totally Legit Police Report”. *See* Amended Complaint, Exhibit F. The fake police report is attached as Exhibit H hereto. While the link was apparently recently removed from the main website, it is still accessible on the www.gb1990.net mirror site (along with the link to FoxNewsBoycott.com, which as previously discussed sells merchandise that criticizes Mr. Beck).

² While not directly germane to these proceedings, it bears mentioning that there similarly is a tension between the First Amendment right to free speech and defamation laws. However, as explained by the United States Supreme Court in *Gertz v. Robert Welch, Inc.*, 418 U.S. 323, 339-40 (1974),

[T]here is no constitutional value in false statements of fact. Neither the intentional lie nor the careless error materially advances society's interest in ‘uninhibited, robust, and wide-open’ debate on public issues. New York Times Co. v. Sullivan, 376 U.S., at 270. They belong to that category of utterances which ‘are no essential part of any exposition of ideas, and are of such slight social value as a step to truth that any benefit that may be derived from them is clearly outweighed by the social interest in order and morality.’ Chaplinsky v. New Hampshire, 315 U.S. 568, 572 (1942).

The statement made by Respondent in his domain name, *i.e.*, that Mr. Beck raped and murdered a young girl in 1990, falls within the category of statements which are *per se* defamatory and which are not protected by the First Amendment. *See e.g., Bryson v. New Am. Pub., Inc.*, 672 N.E.2d 1207, 1221 (Ill. 1996) (finding statement that plaintiff was “slut” was “not so fanciful or ridiculous that no reasonable person would interpret it as describing

with respect to terms protected as trademarks or service marks. Rights granted to trademark owners operate as a limited restriction on freedom of speech.”) (citation omitted)

For example, in *Anheuser-Busch, Inc. v. Balducci Pub.*, 28 F.3d 769 (8th Cir. 1994), the Eighth Circuit Court of Appeals found that a purported advertising parody using Anheuser-Busch’s trademarks not only was likely to confuse consumers for purposes of a trademark infringement claim, but also constituted trademark dilution and tarnishment because the advertisement suggested that Anheuser-Busch’s products were contaminated with oil. The court found that the defendants “unsupported attack was not even remotely necessary to Balducci’s goals of commenting on the Gasconade oil spill and water pollution generally.” *Id.* at 778. Likewise, the wrongful acts of Respondent in making the plain and maliciously false factual statement that Mr. Beck committed the horrific crimes of rape and murder of a child in the Disputed Domain Name cannot possibly fall within the protected ambit of speech that could be directed at Mr. Beck and thus unlawfully tarnishes his trademarks.

B. The Purpose of this URDP Action is Not To Censor Criticism of Glenn Beck

Respondent’s assertion that granting the relief Complainants seek would “censor ... criticism”, Response, p.3, is utterly baseless. Respondent has registered at least three other domain names which host and/or mirror Respondent’s website, none of which are the subject of the instant WIPO Proceeding.

Complainants do not dispute Respondents’ right to criticize Complainants’ activities; in fact, Mr. Beck is an ardent supporter of the First Amendment right of free speech. Instead, Complainants’ action is directed at the wrongful acts of Respondent in his registration of a domain name that completely subsumes the trademark “Glenn Beck” and links that trademark with raping and murdering a child, thus constituting bad faith registration, not protected speech.³

Respondent’s failure to distinguish the Disputed Domain Name as a protest site in the domain name itself establishes that Respondent’s registration of the Disputed Domain Name was done in bad faith. *See e.g., Justice for Children v. R neetso/Robert W. O’Steen*, WIPO Case No. D2004-0175 (finding registration in bad faith despite lack of evidence establishing the typical categories of bad faith, explaining “Respondent’s registration and continued use were undertaken intentionally and expressly to disrupt Complainant’s activities, to prevent Complainant from making use of its own mark in two popular top-level domains, and to expand the audience for his criticism by misleading Internet users as to the ‘source, sponsorship, affiliation, or endorsement’ of his website, by means of the initial confusion discussed [above.]”); *Union Square Partnership, Inc. et al. v. unionsquarepartnership.com Private Registrant et al.*, WIPO Case No. D2008-1234 (“Respondent may criticize, complain, parody, or otherwise express her views about

actual persons or events” and rejecting defendant’s argument that the statement cannot be reasonably interpreted as stating actual facts because the story was labeled “fiction”)

³ In this respect, this case is distinguishable from this Panel’s decision in *Sutherland Institute*. Here, Respondent plainly acted in bad faith because the Disputed Domain Name in and of itself tarnishes Complainants’ trademarks and service marks. WIPO Rules should not permit the registration of domain names that clearly dilute or tarnish the reputation of a trademark or are otherwise defamatory merely with the justification that there may be some free speech elements on the website to which the domain name resolves.

Complainant or anyone else, on the Internet or in any other medium she chooses – but not from Complainant’s soapbox, billboard, or broadcast frequency.”) Thus, this case is unlike the “sucks” cases to which Respondent cites, in which it is unambiguously apparent from the domain name itself that the website is a protest site.

C. Respondent Improperly Skews the Perspective Away From the Average Internet User

Respondent callously states that only an “imbecile” or a “moron in a hurry” would be confused by his self-described “joke”. Yet, Respondent dedicates three and a half pages of his 17-page Response to explain it. The fact that Respondent has to work so hard to explain why the domain name is a “joke” undermines his argument that it is unreasonable to believe that there could be no confusion when an average internet user comes upon the domain name.

Indeed, there apparently has been enough confusion that Respondent found it necessary to change his purported “disclaimer” a number of times since he first put up his website. Compare Exhibit I (copy of Respondent’s website as of September 2, 2009) with Exhibit J (copy of Respondent’s website as of September 11, 2009), both attached hereto. Currently, it states:

Notice: This site is parody/satire. We assume Glenn Beck did not rape and murder a young girl in 1990, although we haven't yet seen proof that he didn't. But we think Glenn Beck definitely uses tactics like this to spread lies and misinformation.

*Read the last sentence again. That's the point. Read it a third time and ignore the name of the site itself, because anyone who believes that we're trying to actually get people to believe Glenn Beck raped and/or murdered is *whoosh* missing the entire point. So don't be dumb like a lot of people are. I greatly expanded this text because so many people *read* it, and *still* didn't understand.(emphasis added)*

Notwithstanding the fact that the purported “disclaimer” does not really disclaim anything, Respondent’s admission that “so many people *read* [the disclaimer] and *still* [do not] understand” proves that people have been confused by the Disputed Domain Name. Likewise, Respondent’s request that the user “ignore the name of the site itself” is telling as “the name of the site itself” is what these proceedings are all about.

Moreover, Respondent’s counsel stated in an October 8, 2009 interview on *Declaring Independence with Ed Brayton* on WPRR 1680-AM in Grand Rapids, Michigan that:

... the joke itself is not that easy to get and it's one in a string of many internet jokes otherwise known as internet memes. And I really feel like if you are going to understand the case, you've got to be in on the joke. And you can't be in on the joke unless you come down to my client's level a little bit. . . .

This statement highlights why Respondent’s position is wrong.

While the Respondent may think that in-crowd users of social news aggregator websites like Fark, Digg or Reddit may “get it” because the users tend to be more internet savvy and “in the know”,⁴ the average internet user will not only not get the self-described, alleged “joke”, but also would quite reasonably believe the falsely maligning statement to be taken literally as one that is intended to be true. An average internet user doing a search on Mr. Beck’s name is merely going to see the domain name “GlennBeckRapedAndMurderedAYoungGirlIn1990.com”. There is nothing in the Disputed Domain Name that tells the reader that it is a “joke”. There is nothing in the Disputed Domain Name to lead an average internet user to expect a criticism site. There is nothing in the Disputed Domain Name that distills the long history of internet memes and explains how this domain name purports to fit into that history. And, there is certainly nothing in the Disputed Domain Name that explains that it is allegedly a play on an August, 2008 comic routine by Gilbert Gottfried. Indeed, as this Panel explained in *Sutherland Institute*:

In the traditional copyright defense, the copyright “parodist” has drawn the reader, viewer or listener to his or her work by first appearing to be the original, and then changing direction to make fun of or criticize the original. It is important to a parody defense that the distinction between the parody and original work ultimately be sufficiently clear. The parodist should not make such extensive use of the original work as to essentially rely on the original for its expressive effect. In other words, the parodist must not merely be re-packaging and selling the original.

Here, Respondent is repackaging an obscure comedy routine by someone else and claiming that is somehow is a parody of Mr. Beck’s rhetorical style. However, Gilbert Gottfried made that comment, not Mr. Beck. Respondent’s domain name thus would not constitute parody under United States law. *See Sutherland Institute, supra* (finding no parody where respondent did not transform the complainant’s service mark).

Put simply, there is no way for the average person to know the context of the Disputed Domain Name when he or she sees it by itself – all they see is the clear, factual statement: “Glenn Beck Raped And Murdered A Young Girl in 1990.” When viewed from the proper perspective, it is clear that there will be confusion between the Disputed Domain Name and Complainants’ trademarks.

D. Respondent’s Newly Minted Reasons for Registering the Website Are Merely Self-Serving Rationalizations and Should Be Discounted

There is no credible evidence that Respondent had any of the lofty goals he ascribes to himself in his Response when he actually registered the Disputed Domain Name. Indeed, as seen in a September 5, 2009 Reddit.com posting, Respondent (under his alias “Daychilde”) explains in response to a question of why Respondent’s website was “The Official Website About the Controversy”,

Basically, I registered the domain. It was as simple as that. And I was there for the start of the meme in the Fark thread. :)

⁴ Indeed, Fark users pride themselves on the fact that: “Nothing is obscure on Fark”.

A copy of the September 5, 2009 Reddit.com posting is attached hereto as Exhibit K.

All of the quotes and You Tube video transcripts that Respondent cherry picked to include his Response as a means of criticizing Mr. Beck's "rhetorical style" are merely *post-hoc* explanations and rationalizations for a domain name he registered in bad faith. As seen in the earliest printout of the website at the Disputed Domain Name (from September 2, 2009, Respondent only sites to the "Origin" of the purported meme at Fark.com. It was not until later that Respondent put up a link to the August, 2008 Gilbert Gottfried routine.⁵ See Ex. J. The Panel thus should not be taken in by Respondent's recent rationalizations.

E. Another Factual Discrepancy

In asserting that Complainants' intent to use applications should have "no value" in these proceedings, Respondent misinterprets Exhibit D, the Trademark Office's September 17, 2009 status report, by arguing that one of Complainants' applications was not likely to mature to registration at the time when Complainants' original WIPO Complaint was filed. This is simply untrue. Mercury Radio Arts, Inc. filed a Statement of Use on August 10, 2009, weeks before the Disputed Domain Name was registered. However, regardless of the status of the trademark application, Beck still claims common law trademark rights in his name as well. See *Tom Cruise v. Network Operations Center/Alberta Hot Rods*, WIPO Case No. D2006-0560 (in ordering transfer of domain name, found actor Tom Cruise has common law trademark and service mark rights in his name).

F. Conclusion

In sum, Complainants respectfully assert that the Panel should issue a decision transferring the Disputed Domain Name to Complainants.

Complainants certify that the information contained in this Supplemental Filing is to the best of Complainants' knowledge complete and accurate, that this Supplemental Filing is not being presented for any improper purpose, such as to harass, and that the assertions in this Supplemental Filing are warranted under these Rules and under applicable law, as it now exists or as it may be extended by a good-faith reasonable argument.

⁵ Strangely, the interview with Congressman Keith Ellison to which Respondent places so much importance to prove Mr. Beck's alleged "rhetorical style" took place in November 2006, approximately a year and a half before the Bob Saget Roast in August 2008 where Gilbert Gottfried performed. Complainants are unclear how Mr. Beck can be alleged to be using the "Gottfried Technique", which was perfected later. Regardless, Respondent's careless manipulation of the facts further shows why the domain name cannot be considered a parody.
