This office represents Brent Hanson in connection with the above-referenced matter. On July 1, 2011, Judge Trena H. Burger-Plavan issued an Order staying the above-entitled matter pursuant to Plaintiff Glenn Hagele's Request for Accommodations by Persons with Disabilities. A copy of the Order is attached to this letter. By the terms of the Order, the matter was stayed until December 11, 2011.

On May 24, 2011, we filed a Motion to Dismiss Plaintiff's Complaint Pursuant to C.C.P. §§ 583.310 and 583.410, which was to be heard on July 21, 2011 at 2:00 PM in Department 53. On June 30, 2011, we filed a Motion for Summary Judgment, which was scheduled to be heard on September 16, 2011 at 2:00 PM in Department 53. The hearings on both of these motions were vacated pursuant to the Court's Order staying the matter. As the stay is now lifted by the terms of the Order, we are requesting that the hearings on both of these motions be rescheduled. Under the circumstances, we request that the Motion to Dismiss be heard on or after January 16, 2012, and that the Motion for Summary Judgment be heard on or after March 19, 2012. Scheduling these


