The *Amended Complaint*, like its predecessor, is deeply flawed because it is a transparent attempt by a political candidate to sue two student reporters for factual reporting which was not to the candidate's liking. Such reporting is protected by the United States Constitution and the Vermont Constitution, and the claims must be dismissed and the student reporters granted their
