VERIFIED COMPLAINT

Plaintiff, HORIZON GROUP MANAGEMENT, LLC, an Illinois limited liability company ("Plaintiff"), by its attorneys, complains against Defendant, AMANDA BONNEN ("Defendant") as follows:

1. At all times mentioned below and prior and subsequent to thereto, Plaintiff was and still is a limited liability company duly organized and existing under Illinois law, with its principal office and place of business in Chicago, Cook County, Illinois. Plaintiff conducts business under the name "Horizon Realty Group," "Horizon Group" and "Horizon" and is recognized as one of Chicago's premiere apartment leasing and management companies because it understands the importance of quality customer service and a well-maintained living environment.

2. Defendant is now, and at all times mentioned below was, a person residing in Chicago, Cook County, Illinois. She was a tenant of Plaintiff, residing at 4242 N. Sheridan Road, Chicago, Illinois.

3. At the time of the commission by Defendant of the grievances mentioned below, and for a long time before then, Plaintiff was a company of good name, fame, and reputation and

was deservedly held in high esteem by and among renters, potential renters and the general public.

4. Twitter is a free social network on the World Wide Web that allows users to send and read messages; the messages are referred to as 'Tweets.' Tweets are posts of up to 140 characters and are displayed on the Tweet author's profile page and are delivered to the author's followers.

5. A person with a Twitter account can make his or her profile page private or public. If the account is private, only persons approved by the account holder can view his or her profile page and receive account updates. If the account is public, anybody in the world can view the account holder's Tweets.

6. Defendant's Twitter account is public.

7. On or about 9:08 am on May 12, 2009, in Chicago, Illinois, Defendant maliciously and wrongfully composed and wrote a certain Tweet. The Tweet contained false and defamatory matter concerning Plaintiff, namely: "...Who said sleeping in a moldy apartment was bad for you? Horizon realty thinks it's okay." A copy of the Tweet is attached as Exhibit A.

8. Defendant then and there maliciously and wrongfully published the false and defamatory Tweet on Twitter, thereby allowing the Tweet to be distributed throughout the world.

9. The statements in the Tweet concerning Plaintiff were and are wholly false. By reason of the publication of them, Plaintiff has been greatly injured in its reputation as a landlord in Chicago.

10. Because the statement damaged the Plaintiff's reputation in its business, the statement is liable per se. Damages are presumed.

WHEREFORE, Plaintiff, HORIZON REALTY GROUP, LLC, an Illinois limited liability company, respectfully requests that judgment be entered in its favor and against Defendant, AMANDA BONNEN, in the amount in excess of \$50,000 and court costs to the date of entry of judgment and the costs of suit herein, and any other relief this court deems just and proper.



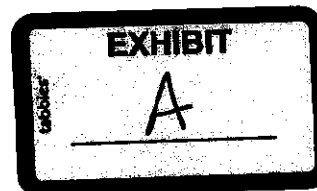

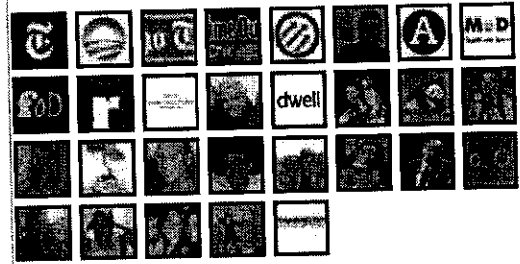
